



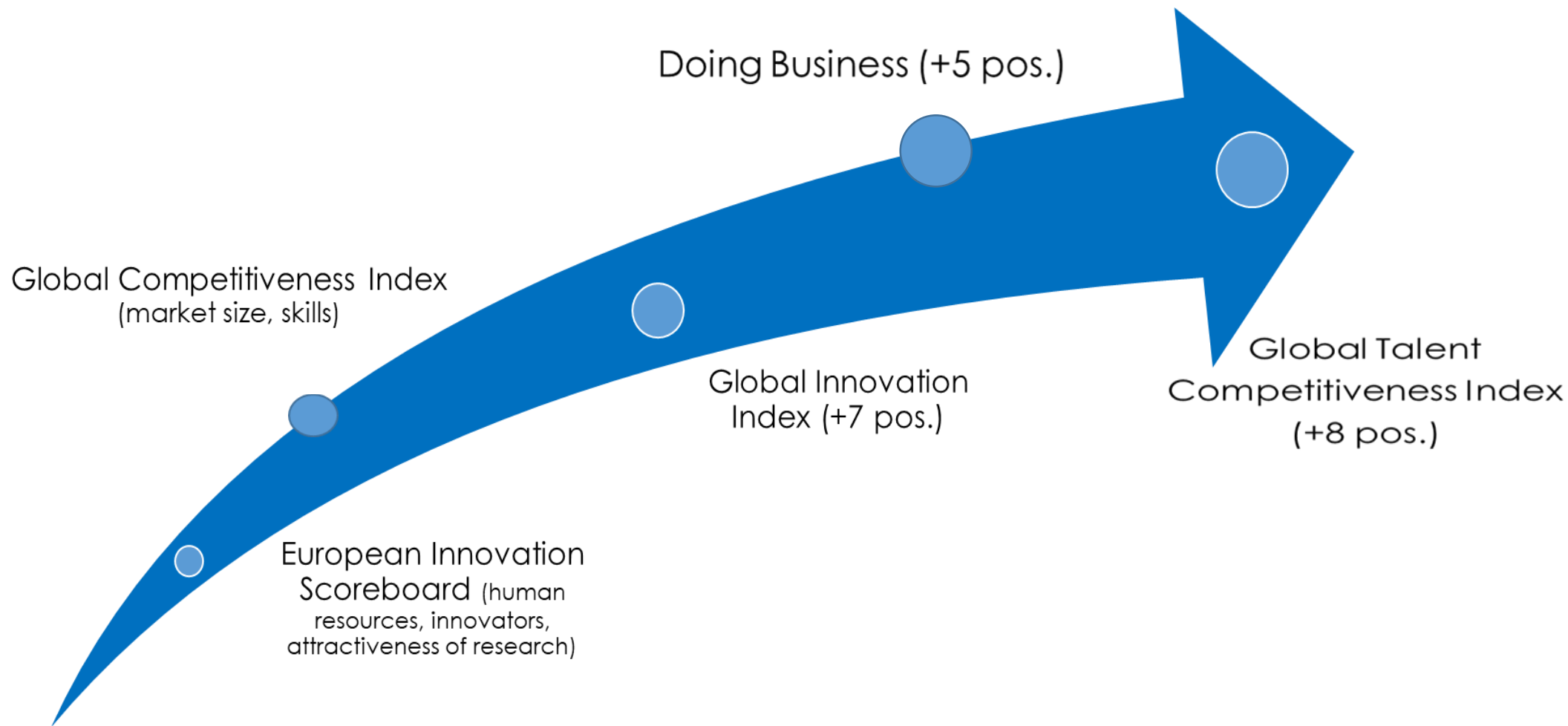

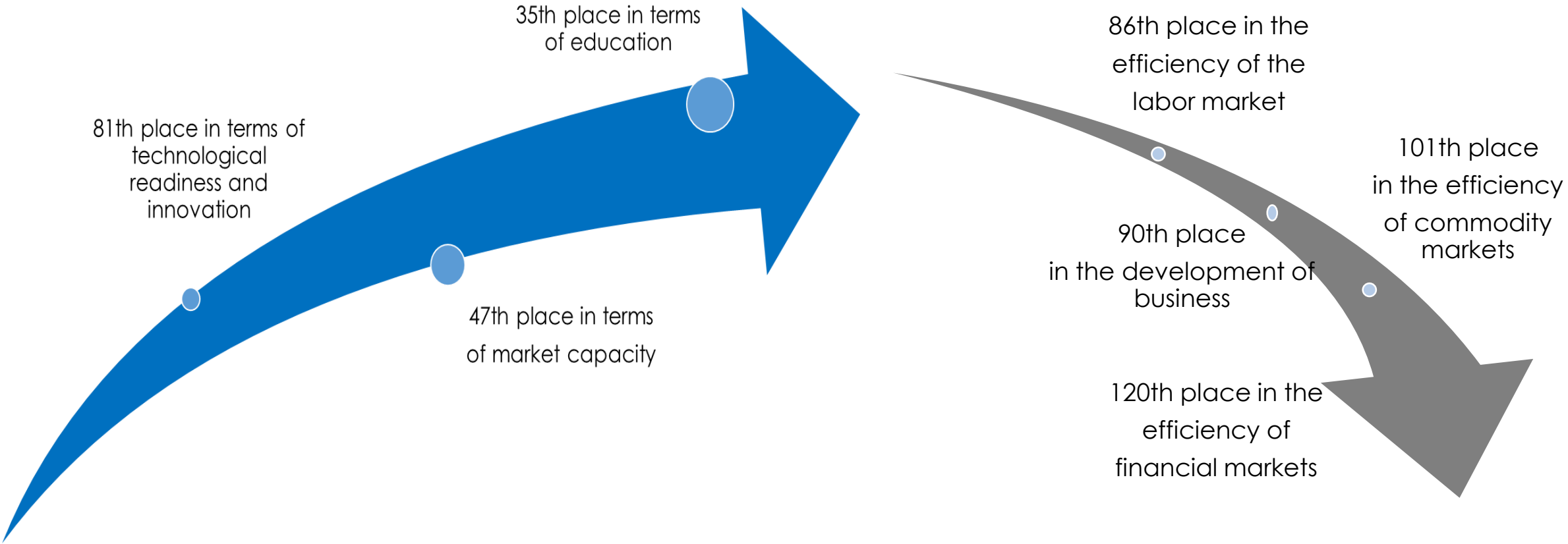

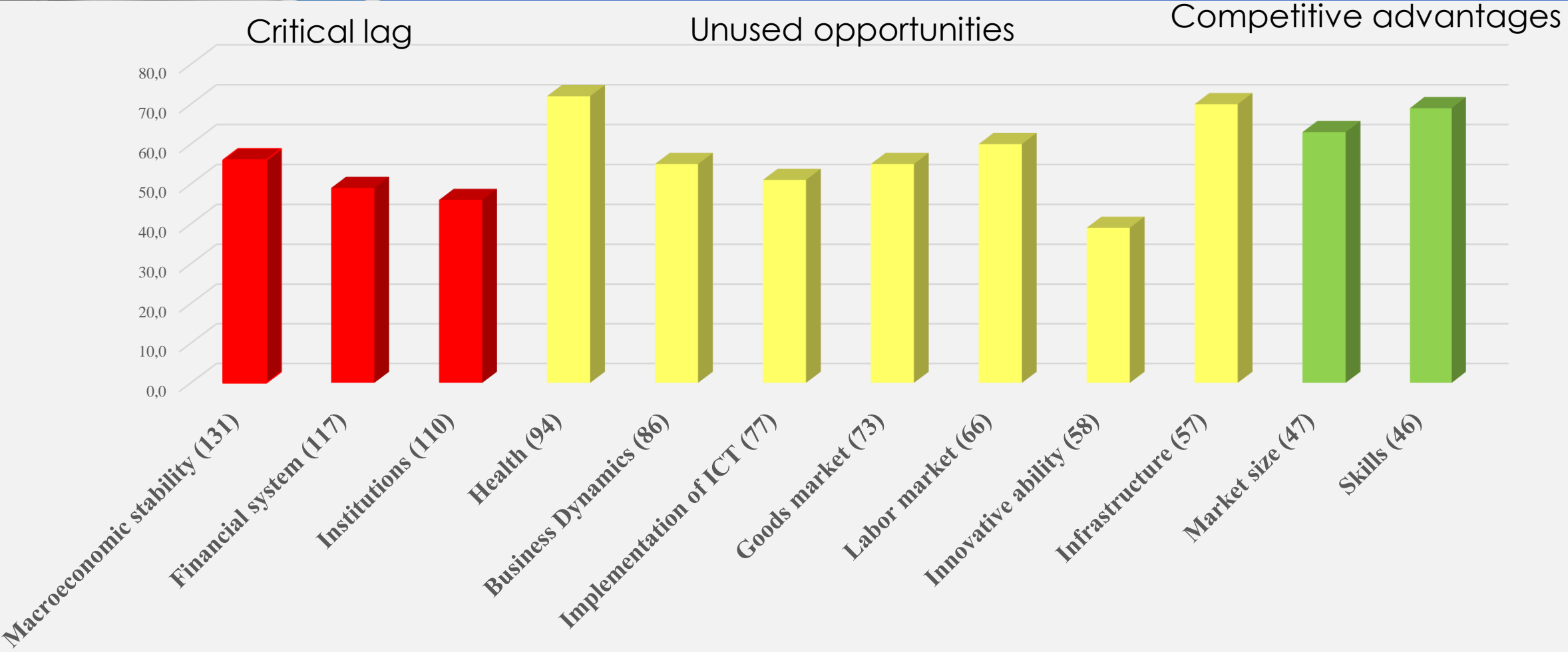

Strategy of Innovative Development

The Ministry of Education and Science of Ukraine has developed a Strategy of Innovative Development

The **main goal** of the Strategy is to create the innovative ecosystem of Ukraine to ensure the rapid and qualitative transformation of creative ideas into innovative products and services.



Problem solving

legal regulation of innovation activity

- updating the terminology database
- creation of a favorable legal and regulatory framework
- creation of favorable conditions for the development of the market of venture capital

methodological support

- development of innovative infrastructure on the basis of institutions of higher education and scientific institutions
- training of personnel in the innovation sphere
- development of connections of domestic scientists and inventors with Ukrainian and foreign enterprises



Problem solving

educational activities

- ensuring the success of a youth career after graduation from a higher education institution
- creation and implementation of educational programs on innovative entrepreneurship and financial literacy

cultural activities

- information activities, enhancement of the culture of academic entrepreneurship in NGOs and academic institutions
- increasing the skills of scientists and inventors on the issues of commercialization of technologies and other objects of intellectual property rights



The first steps to be implemented in **2019** are:

STEP	RESULT
To eliminate legal conflicts and gaps in the regulation of relations in the field of innovation and technology transfer	The Laws of Ukraine «On State Regulation of Activities in the Field of Technology Transfer», «On Priority Areas of Innovation Activity in Ukraine» and «On Science Parks» have been amended
To update the list of critical technologies in the field of production of armaments and military equipment	The legal act, that defines the new list of critical technologies in the field of production of armaments and military equipment, has been approved



The first steps to be implemented in **2019** are:

STEP	RESULT
To develop an audit mechanism for technologies created at the expense of budget funds	The legal act, that defines the audit mechanism for technologies created at the expense of budget funds, has been approved
To create a network of innovative structures: business incubators, technology transfer offices etc.	Three pilot regional technology transfer centers and five technology and innovation support centers have been created
To provide the support for innovators to get the access to international grant funds	The selection and funding of projects under the Program «EUREKA» have been made



The first steps to be implemented in **2019** are:

STEP	RESULT
To raise awareness of innovation activity	Trainings and seminars for experts in technology transfer have been organized and conducted
To organize measures aimed at developing a culture of entrepreneurship	All-Ukrainian Innovation Festival, conference and international forum «Innovation market» have been held



Expected results of the Strategy implementation

increase in the number of people involved in the invention

increase in the number of people providing services for the commercialization of technological solutions

increase in revenue from the sale and use of intellectual property

increase in the share of investments in intangible assets of the total capital investment

increase in the share of enterprises engaged in innovations

increase in the number of startups
